

It is vital that publicly-accessible premises consider terrorist threats so that vulnerabilities can be identified, reduced and managed.

NEBOSH has developed its NEBOSH International Certificate in Protecting Premises and Events from Terrorism to help organisations achieve this.

Who's it for?

This course is for health and safety professionals and other workers who are involved in ensuring that their organisation has considered and addressed the threat of terrorism in premises open to the public. This qualification is not designed for security professionals or SHE professionals with extensive security management or counterterrorism experience.

What will I learn?

This three-day course will help you:

Understand terrorism and its legal context

- Recognise the nature of terrorism, including motivations and common ideologies.

- Understand relevant legislation, health and safety frameworks, and the role of enforcement agencies.

Assess the potential terrorism threat facing your organisation

- Interpret national terrorism threat levels and intelligence guidance to support proportionate, context-specific decisions.
- Identify terrorist threats and site-specific vulnerabilities.

Identify protective procedures and measures and the appropriate emergency response

- Implement effective anti-terrorism protection procedures and the appropriate emergency response.
- Communicate and coordinate with emergency services and other agencies.
- Select and justify layered protective security measures using established models.

Achieve compliance and post-incident actions

- Document protection procedures and conduct assessments to identify vulnerabilities, evaluate risks, and prioritise controls.
- Outline immediate and longer-term organisational actions following a terrorist incident, including investigation, staff welfare, and continuous improvement.

Promote a positive security culture

- Recognise the importance of effective leadership and engaging workers at all levels.

How is the qualification assessed?

A multiple-format assessment is completed after the course.
